Request for Funding – Shared Server

Pauline VanOverbeke presented a proposal to share the use of an off-site server with Redwood SWCD and Lincoln SWCD that would be operated by Southwest West Central Cooperative Services. The agreement would include 500 GB of storage space backed up in 2 locations, remote desktop access, virus protection, and website and email hosting. The start-up cost would be \$4453.64 with annual cost of \$1,124.39, but the costs could go down if more partners enter in the agreement. The capacity of the server is only about half full at this time with the 3 proposed users.

M/S/P to table discussion on entering an agreement for a shared server until 2017 budgeting is underway and further research can be completed to determine current needs and other suitable options for these services.

Request for Funding – Small Dam Repair

Kerry Netzke presented a request for funding from Luke Moore in the amount of \$2,500 for repair of a small dam located in Nordland Township Section 34. The project provides pre-treatment to the Sonstegard Dam and the work is estimated to cost \$39,207.85. Area II River Basins Projects will provide 75% funding through state bonding money and Moore is responsible for funding or securing cost share funds for the remaining 25%.
